PRIVACY POLICY

We at TRUVETTA CORPORATION/VITARGO PHILIPPINES value your privacy and ensure that appropriate measures are and will be taken to protect your data and reflected in every process where your personal data is involved. Such measures are implemented through our information security management system and privacy policies established in accordance with the principles of proportionality, transparency, and legitimacy of purpose.

The Privacy Policy explains:

- 2. How your personal data will be used, disclosed, shared, retained and disposed
- 3. How to view, change, remove or withdraw personal data, and all that involves in exercising your rights under the law as subject of these data

PERSONAL DATA COLLECTED

Our website also collects your personal data through the form in our "Contact Us" page for inquiries. We collect only the following information:

- 3. Phone Number

Our website also collects your personal data through the form in online shop's checkout page. We collect only the following personal information:

- 1. Name
- 2. E-mail
- 3. Contact Number
- 4. Delivery Address/es
- Credit Card Details

None of your credit card details are stored with us, as we usually do not collect such details to process your payment or for customer service purposes. Instead, our third-party payment processors collect, process and store your credit card details in accordance to their terms of use and private policies. However, in cases of processing refunds, we may collect your bank account details.

We may also collect your Personal Data in circumstances where such collection does not require consent under Applicable Laws.

Please ensure that all Personal Data submitted to us is complete, accurate, true and correct. Failure to do so may result in our inability to provide you with the products and services you have requested.

NON-PERSONAL DATA

- I. We may collect non-personal identification from users whenever they interact with our Site:
 - 1. Browser name
 - 2. Type of computer
 - 3. Technical Information, such as operating system and Internet Service Provider

II. Web browser cookies

Our website may use "cookies" to enhance user experience. Cookies are small files which are used for tracking users' information and stored in computer's hard drive for record-keeping purposes. HOW WE USE YOUR INFORMATION

HOW WE SHARE YOUR INFORMATION

- I. We may use third party service providers to help us operate our business and administer our Site for promotional activities on our behalf, such as sending out newsletters or survey forms.
- II. Data may be shared for commercial purposes, provided it is within the consent you gave. Commercial purposes include direct marketing and marketing, marketing data analysis, and customer-relationship management.
- III. We may share your personal data with third party service providers and affiliate companies provided that you have given us your consent. Your consent is necessary for your data to be processed by our third party provider, namely:
 - 2Checkout, PayPal for the payment processing of your purchases from our online shop and LBC/ JRS / Mr. Speedy / Grab / Lalamove for courier and delivery services.

- IV. Users may find advertisements and other contents in our website that links to our partners, suppliers, advertisers, licensors, and other third parties. We do not control the contents or links that appear once the linked has been clicked. We are not responsible for the practices employed by the websites linked to and from the TRUVETTA CORPORATION/VITARGO PHILIPPINES Website. In addition, these services, including their content, are constantly changing. These sites and services may have their own privacy policies and customer service policies. Browsing and interaction on any other website, including websites which have a link to our Site, is subject to that website's own terms and policies.
- V. The customer or member shall be provided with the following information prior to collection or before data is shared:
- 1. Identity of the personal information controllers or personal information processors that will be given access to the personal data;
 - 2. Purpose of data sharing;
 - 3. Categories of personal data concerned;
 - 4. Intended recipients or categories of recipients of the personal data

HOW WE STORE, PROTECT, UPDATE, AND RETAIN YOUR INFORMATION

I. TECHNICAL SECURITY

We ensure that appropriate technical security measures are in place to protect your data. Some of these measures are:

- 1. ACCESS CONTROL. Access restrictions are enforced in the use of the Site. Only legitimate users are allowed to use. While this is the case, secrecy of the username, password, and account information, as applicable, is the sole responsibility of the member.

PHYSICAL SECURITY

We adopt appropriate data collection and processing practices and security measures to protect against unauthorized access, alterations, disclosures, or destruction of your personal information.

UPDATES, WITHDRAWAL, AND RETENTION

- 1. BLOCK. Access. You have the right to access or demand access to view of practically everything that will happen to your personal data, which includes but are not limited to the description of the personal data, purpose, collection process, use, distribution, disclosure, storage, disposal, and destruction.

Rectify. You have the right to dispute, under reasonable circumstances, the inaccuracies or errors in your personal data and have it corrected immediately and accordingly.

Erase or block. You have the right to suspend or withdraw, order the blocking, removal or destruction of your personal data from our filing system upon discovery and substantial proof of the conditions enumerated under the law. Be indemnified. You have the right to receive compensation for any damages you have sustained due to inaccurate, incomplete, outdated, false, unlawfully obtained or unauthorized use of your personal data.

Data Portability. You have the right to obtain a copy of electronically processed personal data in an electronic or structured format commonly used. This right highlights the concept of you, being the subject, to which these data pertain to have control over your personal data.
